A regular meeting of the Plainville Housing Authority was held on Thursday, February 15, 2024 at 140 East Bacon Street in the Community Room.

Call to Order: 6:00 pm by Vice-Chair Wehmeyer

I. Approval of Warrants 11-12-13:

Commissioner Spiewak made a motion to approve the November Warrant in the amount of \$29,578.81 for the month of November and the addendum as presented. Commissioner Cooper seconded the motion. Approved 3-0.

Commissioner Spiewak made a motion to approve the December Warrant in the amount of \$32,651.00 for the month of December and the addendum as presented. Commissioner Cooper seconded the motion. Approved 3-0.

Commissioner Spiewak made a motion to approve the January Warrant in the amount of \$15,693.95 for the month of January and the addendum as presented. Commissioner Cooper seconded the motion. Approved 3-0.

II. Approval of Minutes November 16, 2023:

Commissioner Wehmeyer made a motion to approve minutes of November 16, 2023 as presented. Commissioner Spiewak seconded the motion. Approved 3-0.

III. Financial Report:

The Management Agent reviewed the year-end financial reports and stated that the authority ended the year in solid condition. Reserves are at a healthy 82% and all budgetary line items, for PMR standards are within acceptable ranges.

- IV. FY2023 Year-End Reports:

 - The Management Agent shared Public Housing Notice 2023-21, which reviewed the premium and deductible increases in property insurance for all housing authorities.
